General Instructions

- ✓ A \$2,000 filing fee is required for the extension of an oil and gas or gas only lease. If applying for a block of leases, a separate filing fee is required for each lease. Fees may be paid by including a check or money order made payable to the Department of Natural Resources.
- ✓ An application for a one-time lease extension must be received at least 180 days before the expiration date of the primary term.
- ✓ If a one-time lease extension is granted, upon extension, the annual rental increases to \$250/acre for the last three years of the lease extension. However, the rental may be less than \$250/acre if the lessee has exercised reasonable diligence to explore and develop the lease during the primary term.
- ✓ Before applying for a lease extension, it is recommended that you call the Division of Oil and Gas, Leasing Section, and schedule a pre-application meeting. At the pre-application meeting, be prepared to discuss:
 - History of the lease(s).
 - Concrete proposal for exploring, developing, and bringing the specific lease(s) to production.
 - The working interest owners' experience and track record of exploring, developing, and bringing leases into production, especially in Alaska, and especially as related to the specific lease(s).
 - The working interest owners' financial capabilities relative to exploring, developing, and bringing leases into production, especially as related to the specific lease(s).
