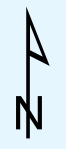


North Slope Oil and Gas Activity 2011

State of Alaska, Department of Natural Resources, Division of Oil and Gas, November 2011



Chukchi Sea OCS

Shell
Granted final air quality permits in September 2011 for 2012-2013 drilling in Chukchi Sea OCS. Plans to use the Noble Discoverer drillship to drill up to 3 wells per drilling season on the Burger prospect in 2012 & 2013.

Statoil
Evaluating Amundsen and Augustine prospects identified by 3-D seismic acquired over Chukchi Sea leases in 2010. Conducted site surveys during summer 2011.

North Slope Borough
Plans to drill exploration and development wells in their East Barrow, South Barrow, and Walakpa gas fields during 2011-2012.

ENI
Nikaitchuq Unit Schrader Bluff PA producing oil since February 2011. Two rotary rigs active September 2011.

Shell
Conditional approval from BOEMRE in August 2011 for exploration plan in Beaufort Sea OCS. Plans to use the Kulluk floating drilling platform to drill up to 2 wells each on Sivulliq and Torpedo prospects in Camden Bay beginning in 2012.

Conoco Phillips
Focused 2010-2011 drilling on CD-1 & CD-2 opportunities because of U.S. Army Corps of Engineers CD-5 permit denial. Corps has remanded some issues for reconsideration.

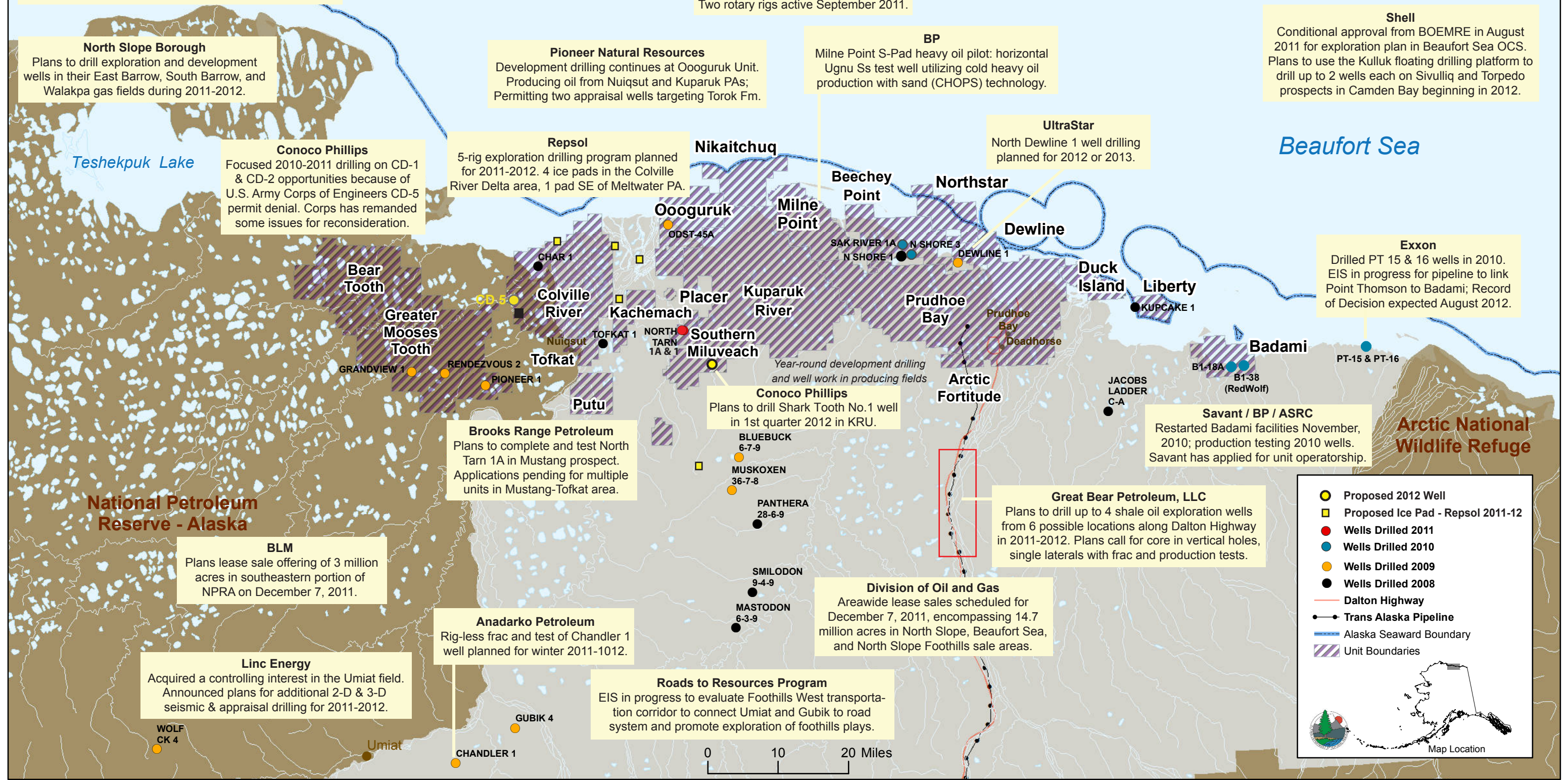
Repsol
5-rig exploration drilling program planned for 2011-2012. 4 ice pads in the Colville River Delta area, 1 pad SE of Meltwater PA.

BP
Milne Point S-Pad heavy oil pilot: horizontal Ugnu Ss test well utilizing cold heavy oil production with sand (CHOPS) technology.

UltraStar
North Dewline 1 well drilling planned for 2012 or 2013.

Exxon
Drilled PT 15 & 16 wells in 2010. EIS in progress for pipeline to link Point Thomson to Badami; Record of Decision expected August 2012.

Brooks Range Petroleum
Plans to complete and test North Tarn 1A in Mustang prospect. Applications pending for multiple units in Mustang-Tofkat area.

Conoco Phillips
Plans to drill Shark Tooth No.1 well in 1st quarter 2012 in KRU.

Savant / BP / ASRC
Restarted Badami facilities November, 2010; production testing 2010 wells. Savant has applied for unit operatorship.

Great Bear Petroleum, LLC
Plans to drill up to 4 shale oil exploration wells from 6 possible locations along Dalton Highway in 2011-2012. Plans call for core in vertical holes, single laterals with frac and production tests.

Division of Oil and Gas
Areawide lease sales scheduled for December 7, 2011, encompassing 14.7 million acres in North Slope, Beaufort Sea, and North Slope Foothills sale areas.

BLM
Plans lease sale offering of 3 million acres in southeastern portion of NPRA on December 7, 2011.

Anadarko Petroleum
Rig-less frac and test of Chandler 1 well planned for winter 2011-1012.

Linc Energy
Acquired a controlling interest in the Umiat field. Announced plans for additional 2-D & 3-D seismic & appraisal drilling for 2011-2012.

Roads to Resources Program
EIS in progress to evaluate Foothills West transportation corridor to connect Umiat and Gubik to road system and promote exploration of foothills plays.
