Division of Oil and Gas is responsible for leasing state land for oil, gas and geothermal exploration, development and production. For general information about each section, go to: <http://dog.dnr.alaska.gov/AboutUs/About.htm>.

- [Leasing](#) section administers oil, gas and geothermal leases and exploration licenses on state land. It conducts regularly scheduled lease sales outline in the [Five-Year Oil and Gas Leasing Program Report](#).
- [Permitting](#) section issues permits, handles lease plans of operations and ensures bond placement before surface exploration.
- [Units](#) section manages lease groupings known as units and reviews and adjudicates annual unit plans of development and the formation, expansion, contraction, and termination of units and participating areas.
- [Resource Evaluation](#) oversees the regulatory side of reservoir management and evaluates oil and gas resources.
- [Commercial](#) section does contract negotiations, economic analysis, and provides expertise to support oil and gas policy and regulations.
- [Royalty Accounting](#) tracks royalty ownership, conducts audits, and allocations royalty revenue from each producing property.
- [Royalty Audit](#) makes sure that the state received full value of royalty payments.
- [PSIO](#) – Petroleum Systems Integrity Office leads inter-agency oil and gas facility maintenance oversight, and coordinates with other state/federal agencies and the industry.
- [GIS, IT & Admin](#) section provides support services with custom in-house applications, map publications and administrative services.
