AS 43.90.150(a)	"At the request of the applicant, information submitted under this chapter that the applicant identifies and demonstrates is proprietary or is a trade secret is confidential and not subject to public disclosure under AS 40.25. After a license is awarded, all information submitted by the licensee, retained under this chapter, and not determined by the commissioners to be a proprietary or trade secret shall be made public."	<input type="checkbox"/>	
AS 43.90.220(e)	"All proprietary information, privileged information, and trade secrets received by the commissioners or their representatives under (d) of this section are not subject to public disclosure under AS 40.25." AS 43.90.220(d): "After a license has been issued and until commencement of commercial operations of a natural gas pipeline, the licensee shall allow the commissioners to (1) have a representative present at all meetings of the licensee's governing body or bodies and equity holders that relate to the project; (2) receive all relevant notices and information when and as sent to the governing body or bodies and equity holders; (3) enjoy the same access to information about the licensee as the governing body members and equity owners receive; and (4) receive relevant reports or information from the licensee that the commissioners reasonably request."	<input type="checkbox"/>	
AS 45.50.910-45.50.940	AS 45.50.940(3): "'trade secret' means information that (A) derives independent economic value, actual or potential, from not being generally known to, and not being readily ascertainable by proper means by, other persons who can obtain economic value from its disclosure or use; and (B) is the subject of efforts that are reasonable under the circumstances to maintain its secrecy."	<input type="checkbox"/>
