POINT THOMSON EXPORT PIPELINE
RIGHT-OF-WAY LEASE APPLICATION
DATED AUGUST 04, 2010

The Commissioner of the Department of Natural Resources, pursuant to AS 38.35.070, hereby gives notice that PTE Pipeline, LLC submitted an application dated August 04, 2010, in accordance with the Alaska Right-of-Way Leasing Act, AS 38.35.050, for a proposed Point Thomson Export Pipeline right-of-way lease.

PTE Pipeline, LLC proposes to construct an above ground pipeline to transport Liquid Hydrocarbons. The proposed pipeline will extend from the Pt. Thomson Central Pad to the existing Badami Sales Oil Pipeline, both located on the North Slope of Alaska. The proposed pipeline right-of-way will contain one 12.75" diameter pipe. The pipeline design maximum throughput is approximately 70,000 barrels cubic per day.

Construction is scheduled to begin in late 2011 with project completion projected for 2014. Operations are scheduled to commence in 2014. PTE Pipeline, LLC has requested a 400' foot wide right-of-way for construction of the pipeline and a 100' foot wide permanent right-of-way. During construction, the right-of-way on state owned or managed lands will be approximately 1,066 acres. This will be reduced, post-construction, to approximately 266.5 acres for the permanent right-of-way. The proposed right of way will traverse:

Township 10N Range 23E Umiat Meridian, Sections 31, 32, 34
Township 09N Range 23E Umiat Meridian, Sections 3, 4, 5, 6
Township 10N Range 22E Umiat Meridian, Sections 31, 33, 34, 35, 36
Township 09N Range 22E Umiat Meridian, Sections 1, 2, 3, 4, 5, 6
Township 10N Range 21E Umiat Meridian, Sections 34
Township 09N Range 21E Umiat Meridian, Sections 1, 2, 3, 7, 8, 9, 10, 11, 18
Township 09N Range 20E Umiat Meridian, Sections 8, 9, 10, 11, 12, 13, 14, 15, 16

The proposed pipeline will be above ground for its entire 22 mile length and will be located entirely on land owned by the State of Alaska.

Alaska Statute 38.35.200 governs judicial review of decisions of the commissioner's application:

38.35.200. Judicial review of decisions of commissioner on application.

- (a) An applicant or competing applicant or a person who has direct financial interest affected by the lease who raises objections within 60 days of the publication of notice under AS 38.35.070 are the only persons with standing to seek judicial review of a decision of the commissioner under AS 38.35.100.
- (b) The only grounds for judicial review of a decision of the commissioner are
 - 1. failure to follow the procedures set out in this chapter; or
 - 2. abuse of discretion so capricious, arbitrary, or confiscatory as to constitute a denial of due process.
