
This is an Amendment to Exhibit D Description of the Right-of-Way for Related Facilities of the RIGHT-OF-WAY LEASE FOR THE TRANS-ALASKA PIPELINE dated May 3, 1974, ADL 63574, which was recorded in the Fairbanks Recording District in Book 149 Pages 0799 through 0905 on July 16, 1979, hereinafter this document is referred to as AMENDMENT. This AMENDMENT is made and entered into and becomes effective this 2 day of June, 1994 by and between the State of Alaska located at 411 West 4th Avenue, Suite 2C, Anchorage, Alaska 99501 acting through the Commissioner of the Department of Natural Resources hereinafter referred to as COMMISSIONER and Alyeska Pipeline Service Company as agent for Amerada Hess Pipeline Corporation, ARCO Transportation Alaska, Inc., BP Pipelines (Alaska) Inc., Exxon Pipeline Company, Mobil Alaska Pipeline Company, Phillips Alaska Pipeline Corporation, and Unocal Pipeline Company located at 1835 South Bragaw Street, Mailstop-569, Anchorage, Alaska 99512 hereinafter referred to as LESSEE.

WHEREAS, the LESSEE has applied to amend the existing Right-of-Way Lease ADL 63574 to include an additional 0.30 acres of land within the Fairbanks Recording District included in the Hess Creek Erosion Control Structure. The lands are located at the Hess Creek pipeline bridge south abutment and pipeline workpad at pipeline milepost 378.7 within Section 20, Township 10 North, Range 7 West, Fairbanks Meridian, Alaska as depicted on the as-built drawing entitled Hess Creek Bank Protection Proposed Right-of-Way dated August 23, 1993. The areas to be added are labeled on the drawing as "Proposed Right-of-Way" on the easterly and westerly sides of the existing pipeline right-of-way.

NOW THEREFORE, the COMMISSIONER and LESSEE agree to amend the RIGHT-OF-WAY FOR THE TRANS-ALASKA PIPELINE dated May 3, 1974, ADL 63574 to include the lands depicted on the drawing dated August 23, 1993, Exhibit A, attached and made a part hereof. These lands are incorporated into and made a part of the RIGHT-OF-WAY LEASE FOR THE TRANS-ALASKA PIPELINE dated May 3, 1974, ADL 63574.




