#### NOTICE OF SALE

#### NORTH SLOPE AREAWIDE 2008 BEAUFORT SEA AREAWIDE 2008 COMPETITIVE OIL AND GAS LEASE SALES

The Alaska Department of Natural Resources (ADNR), Division of Oil and Gas (DO&G), will offer state lands for competitive oil and gas leasing in North Slope Areawide (NS) 2008 and Beaufort Sea Areawide (BS) 2008, oil and gas lease sales on **October 22, 2008**. **Bid opening will begin at 9:00 a.m.** at the Wilda Marston Theater, Loussac Public Library, 3600 Denali St., in Anchorage.

The sale areas are divided into tracts ranging in size from 640 to 5,760 acres. NS has 1,225 tracts and BS has 573 tracts. NS lies between the Arctic National Wildlife Refuge (ANWR) and the National Petroleum Reserve – Alaska (NPPRA). The southern boundary of the NS sale area is the Umiat baseline. BS consists of state-owned tide and submerged lands extending from Pt. Barrow to the Canadian border. BS tracts 27 through 39, located east of Kaktovik, and tracts 555 and 557 through 573, between Tangent Pt and Pt. Barrow, are deferred from this lease sale.

#### North Slope Areawide

- Bidding Method:** Cash bonus bidding with a minimum bid of \$10 per acre on all tracts.
- Royalty Rate:** All tracts north of NS royalty line – a fixed royalty rate of sixteen and two-thirds percent (16.66667%).  
All tracts south of NS royalty line – a fixed royalty rate of twelve and one-half percent (12.5%).
- Length of Lease:** All tracts north of NS royalty line – five (5) years.  
All tracts south of NS royalty line – seven (7) years.

#### Beaufort Sea Areawide

- Bidding Method:** Cash bonus bidding with a minimum bid of \$10 per acre on all tracts.
- Royalty Rate:** Tracts 1 through 26 – a fixed royalty rate of twelve and one-half percent (12.5%).  
All other tracts – a fixed royalty rate of sixteen and two-thirds percent (16.66667%).
- Length of Lease:** Tracts 1 through 26 – ten (10) years.  
Tracts 40 through 77, 500 through 554 and 556 – seven (7) years.  
All other tracts – five (5) years.

#### Rental

Annual rental on all state leases is \$1.00 per acre for the first year, \$1.50 per acre for the second year, \$2.00 per acre for the third year, \$2.50 per acre for the fourth year, and \$3.00 per acre for the fifth and following years.
