**SUPPLEMENTAL NOTICE OF SALE

COMPETITIVE OIL AND GAS LEASE SALES**

On September 28, 2015 the Alaska Department of Natural Resources (DNR), Division of Oil and Gas (DO&G), gave notice pursuant to AS 38.05.945(a)(4) that it is offering state lands for competitive oil and gas leasing in the Beaufort Sea Areawide 2015W (BSA 2015W), North Slope Areawide 2015W (NSA 2015W), and North Slope Foothills Areawide 2015 (FHA 2015) Competitive Oil and Gas Lease Sales.

This is a supplemental notice to the September 28, 2015 Notice of Sale (Notice) issued pursuant to 11 AAC 82.415(c). DO&G is correcting information regarding two lease forms posted online at <http://dog.dnr.alaska.gov/Leasing/SaleDocuments.htm>. Two lease forms used in prior Areawide sales were posted instead of the lease forms referenced in the Notice and BSA 2015W, NSA 2015W, and FHA 2015 Sale Announcement and Instructions to Bidders (Sale Announcements). The terms and conditions of the three Areawide lease sales have not been altered.

- Lease Form DOG 201308W AS was posted for the BSA 2015W and NSA 2015 lease sales and has been replaced with Lease Form DOG 201503W AS.
- Lease Form DOG 201308 was posted for the FHA 2015 lease sale and has been replaced with Lease Form DOG 201503.
