## SUPPLEMENTAL NOTICE OF SALE BEAUFORT SEA AREAWIDE 2017W NORTH SLOPE AREAWIDE 2017W and NORTH SLOPE FOOTHILLS AREAWIDE 2017 COMPETITIVE OIL AND GAS LEASE SALES

On October 6, 2017, the Alaska Department of Natural Resources (DNR), Division of Oil and Gas (DO&G), gave notice pursuant to AS 38.05.945(a)(4) that it is offering State lands for competitive oil and gas leasing in the Beaufort Sea Areawide 2017W (BSA 2017W), the North Slope Areawide 2017W (NSA 2017W), and the North Slope Foothills Areawide 2017 (FHA 2017) Competitive Oil and Gas Lease Sales.

This is a supplemental notice to the October 6, 2017 Notice of Sale (Notice) issued according to 11 AAC 82.415(c). DO&G is offering two lease sale tracts that were previously deferred from the Beaufort Sea Areawide 2017W (BSA 2017W) Competitive Oil and Gas Lease Sale.
