**BEAUFORT SEA AREAWIDE 2021W
SALE INFORMATION**

The Alaska Department of Natural Resources (DNR), Division of Oil and Gas (DO&G), is offering the Beaufort Sea Areawide (BSA 2021W) in the Winter 2021 Competitive Oil and Gas Lease Sales.

Areawide Lease Sale Location

The BSA 2021W lease sale includes approximately 1.7 million acres of state-owned land in 570 tracts, ranging in size from 530 to 5,760 acres. The sale area encompasses primarily offshore acreage that stretches from the Canadian border in the east to Point Barrow in the west. The northern boundary of the Areawide is along the federal Alaska Outer Continental Shelf. The southern boundary is along the North Slope Areawide and includes onshore acreage between the Arctic National Wildlife Refuge and the National Petroleum Reserve – Alaska. The Areawide is in the North Slope Borough.
