## NOTICE OF SALE

### NORTH SLOPE FOOTHILLS AREA WIDE 2004 COOK INLET AREA WIDE 2004 COMPETITIVE OIL AND GAS LEASE SALES

The Alaska Department of Natural Resources (ADNR), Division of Oil and Gas (DO&G), will offer lands for competitive oil and gas leasing in North Slope Foothills Areawide 2004 and Cook Inlet Areawide 2004 Oil and Gas Lease Sales on May 19, 2004. Bid opening begins at 8:30 a.m. in the Wilda Marston Theater, in the Loussac Public Library, 3600 Denali St., in Anchorage.

North Slope Foothills Areawide is divided into 1,347 tracts ranging in size from 1,280 to 5,760 acres. The sale area lies between the Arctic National Wildlife Refuge (ANWR) and the National Petroleum Reserve – Alaska (NPRA). The northern boundary of the sale area is the Umiat Meridian baseline; the southern boundary is the Gates of the Arctic National Park and Preserve.

Cook Inlet Areawide is divided into 815 tracts ranging in size from 640 to 5,760 acres. The sale is located in the Matanuska and Susitna Valleys, the Anchorage Bowl, the western and southern Kenai Peninsula from Pt. Possession to Anchor Pt., on the western shore of Cook Inlet from the Beluga River to Harriet Pt., as well as within Cook Inlet.

#### North Slope Foothills Areawide 2004

**Bidding Method:** Cash bonus bidding with a minimum bid of **five dollars (\$5) per acre** on all tracts.  
**Royalty Rate:** All leases will have a fixed royalty rate of **twelve and one-half percent (12.5%)**.  
**Length of Lease:** All leases will have a term of **ten (10) years**.

#### Cook Inlet Areawide 2004

**Bidding Method:** Cash bonus bidding with a minimum bid of **five dollars (\$5) per acre** on all tracts.  
**Royalty Rate:** All leases will have a fixed royalty rate of **twelve and one-half percent (12.5%)**.  
**Length of Lease:** All leases will have a term of **seven (7) years**.  
**EICs:** XX offshore tracts have been assigned an Exploration Incentive Credit (EIC) of **\$200.00 per foot** drilled for the first exploratory per tract, **not to exceed 20% of the total exploratory well costs**. Credit may be earned for one well per lease during the first three years of the primary term, and is inclusive of other allowed exploration and development credit programs. #### Rental

Annual rental on all state leases is \$1.00 per acre for the first year, \$1.50 per acre for the second year, \$2.00 per acre for the third year, \$2.50 per acre for the fourth year, and \$3.00 per acre for the fifth and following years.


