## NOTICE OF SALE

### BEAUFORT SEA AREAWIDE 2002 NORTH SLOPE AREAWIDE 2002 COMPETITIVE OIL AND GAS LEASE SALES

The Alaska Department of Natural Resources (ADNR), Division of Oil and Gas (DO&G), will offer lands for competitive oil and gas leasing in North Slope Areawide 2002 (NSA 2002) and Beaufort Sea Areawide 2002 (BSA 2002) on October 23, 2002. Bid opening begins at 8:30 a.m. in Anchorage at the Wilda Marston Theater, in the Loussac Public Library, 3600 Denali St.

NSA 2002 encompasses approximately 5.1 million acres and is divided into 1,225 tracts ranging in size from 640 to 5,760 acres. The sale area lies between the Arctic National Wildlife Refuge (ANWR) and the National Petroleum Reserve - Alaska (NPR). The southern boundary of the sale area is the Umiat Meridian Baseline. BSA 2002 covers approximately 1.5 million acres of state-owned tide and submerged lands from Barter Island, off ANWR, to Tangent Point, off NPR, and is divided into 516 tracts ranging in size from 40 to 5,760 acres.

#### North Slope Areawide 2002

**Bidding Method:** Cash bonus bidding with a minimum bid of ten dollars (\$10) per acre for all tracts.

**Royalty Rates:** Leases issued on State and State/ASRC Tracts 0520 through 0916, 0919, 0920, 0922, 0923, 0925, 0926, 0928 through 0935, 0937 through 1145, and 1147 through 1225 will have a fixed royalty rate of sixteen and two-thirds percent (16.66667%).

Leases issued on State/ASRC Tracts 0917, 0918, 0921, 0924, and 0927 will have a sliding scale royalty rate of sixteen and two-thirds percent (16.66667%) to thirty-three and one-third percent (33.33334%).

Leases issued on all remaining State tracts will have a fixed royalty rate of twelve and one-half percent (12.5%).

**Term of Lease:** All leases will have a term of seven (7) years.

#### Beaufort Sea Areawide 2002

**Bidding Method:** Cash bonus bidding with a minimum bid of one hundred dollars per acre (\$100) on Tract 079 and ten dollars (\$10) per acre on all other tracts.

**Royalty Rates:** Leases issued on Tracts 40 through 77, 500 through 554, and 556 will have a fixed royalty rate of twelve and one-half percent (12.5%). Leases issued on Tracts 133, 134, 136, 137, 139, 140, 142, 143, 145, 146, 148, 149, 151- 154, and 156 - 499 will have a fixed royalty rate of sixteen and two-thirds percent (16.66667%). Leases issued on Tracts 78-132, 135, 138, 141, 144, 147, 150 and 155 will have a fixed royalty rate of twenty percent (20.00%).

**Term of Lease:** Leases issued on tracts 40 through 77, 500 through 554, and 556 will have a term of ten (10) years. Leases issued on all other tracts will have a term of seven (7) years.

**Rental**

Annual rental is \$1.00 per acre for the first year, \$1.50 per acre for the second year, \$2.00 per acre for the third year, \$2.50 per acre for the fourth year, and \$3.00 per acre for the fifth and following years.


