NOTICE OF SALE

BEAUFORT SEA AREAWIDE 2010A NORTH SLOPE AREAWIDE 2010 NORTH SLOPE FOOTHILLS AREAWIDE 2010 COMPETITIVE OIL AND GAS LEASE SALES

The Alaska Department of Natural Resources (ADNR), Division of Oil and Gas (DO&G), will offer state lands for competitive oil and gas leasing in the Beaufort Sea Areawide 2010A (BS 2010A), North Slope Areawide 2010 (NS 2010), and North Slope Foothills Areawide 2010 (FH 2010) Oil and Gas Lease Sales on **October 27**, **2010. Bid opening begins at 9:00 a.m.** in the auditorium of the Anchorage Museum at Rasmuson Center, located at 625 C Street in Anchorage. Please note the location change.

The Beaufort Sea Areawide sale area is divided into 573 tracts ranging in size from 640 to 5,760 acres. These tracts are located within the North Slope Borough and consist of state-owned tide and submerged lands in the Beaufort Sea between the Canadian border and Point Barrow. The sale area is adjacent to both the Arctic National Wildlife Refuge (ANWR) and the National Petroleum Reserve-Alaska (NPR-A). The southern fringe of the sale area includes some state-owned uplands lying between the NPR-A and the ANWR.

The North Slope Areawide sale area is divided into 1,225 tracts ranging in size from 640 to 5,760 acres. These tracts are located within the North Slope Borough between the Canning River and the ANWR on the east and the Colville River and the NPR-A on the west. The southern boundary of the sale area is the Umiat Meridian baseline.

The North Slope Foothills Areawide sale area is divided into 1,347 tracts ranging in size from 1,280 to 5,760 acres. These tracts are located between the ANWR and the NPR-A. The northern boundary of the sale area is the Umiat Meridian baseline and the southern boundary is the Gates of the Arctic National Park and Preserve.

Beaufort Sea Areawide 2010A

Bidding Method: Cash bonus bidding with a minimum bid of \$10 per acre on all tracts.

Royalty Rate: Tracts 1 through 26 – a fixed royalty rate of twelve and one-half percent (12.5%).

All other tracts – a fixed royalty rate of sixteen and two-thirds percent (16.66667%).

Length of Lease: Tracts 1 through 26, 40 through 77, 500 through 554 and 556 – 10 years.

All other tracts – 7 years.

North Slope Areawide 2010

Bidding Method: Cash bonus bidding with a minimum bid of \$10 per acre on all tracts.

Royalty Rate: All tracts north of NS royalty line – a fixed royalty rate of sixteen and two-thirds percent

(16.66667%).

All tracts south of NS royalty line - a fixed royalty rate of twelve and one-half percent

(12.5%).

Length of Lease: All tracts north of NS royalty line – 7 years.

All tracts south of NS royalty line – 10 years.

North Slope Foothills Areawide 2010

Bidding Method: Cash bonus bidding with a minimum bid of \$5 per acre on all tracts.

Royalty Rate: All leases will have a fixed royalty rate of twelve and one-half percent (12.5%).

Length of Lease: All leases will have an initial primary term of 10 years.

Rental

Annual rental on all state leases is \$1.00 per acre for the first year, \$1.50 per acre for the second year, \$2.00 per acre for the third year, \$2.50 per acre for the fourth year, and \$3.00 per acre for the fifth and following years.
