NORTH SLOPE FOOTHILLS AREA WIDE 2001 COMPETITIVE OIL AND GAS LEASE SALE

On February 7, 2001 the Department of Natural Resources, Division of Oil and Gas, gave notice that on May 9, 2001 it will conduct the North Slope Foothills areawide lease sale. The Regional Tract Map for this sale depicted State acreage/State selected as a combined land status. Potential bidders are reminded that **the state cannot issue leases for acreage to which it has not received title by either Tentative Approval (TA) or Patent.** The following townships remain either wholly or partially selected or topfiled with the Bureau of Land Management by Alaska under its statehood entitlement. The state has not received title and does not expect to prior to lease issuance.


