- ✓ Use this application if you are requesting a decrease in rental as identified in Paragraph 5 of the following lease forms: *DOG 201112, DOG 201112AS, DOG 201208W, DOG 201208W AS, DOG 201308W, DOG 201308W AS, DOG 201503W AS, DOG 201503W AS, DOG 201509W.*
- ✓ Please contact the Leasing Section if sustained production has commenced on a lease.
- ✓ Rental reduction will be considered on a lease-by-lease basis, but this application may be used to apply for relief on multiple leases at once.
- ✓ When using this application for multiple leases, the leases must all have the same effective date, primary term, and rental rate structure. Use Section 4 as needed.
- ✓ Rental reduction applications will be accepted no earlier than one year before the lease anniversary date where the rental rate increases above \$10.00 per acre per year.
- ✓ This application must be submitted at least 90 days prior to the lease anniversary date where the rental rate increases above \$10.00 per acre per year (11 AAC 82.466).
- ✓ If a decision to grant a reduction in rental has not been made by the date the annual rental is due, it is the responsibility of the lessee to timely pay rentals according to the schedule of the lease agreement. If rental reduction is granted, the overpaid balance will be refunded.
- ✓ To be considered for a reduction in rent, the Commissioner will consider:
 - The funds expended by the lessee to explore and develop the lease(s).
 - The types of work completed by or on behalf of the lessee
- ✓ If rental reduction is approved, the rental rate will be \$10.00 per acre per year.
- ✓ If the rental rate has not been previously reduced to \$10.00 per acre per year, rental reduction may be applied for annually.
- ✓ You may mail the application to the above mailing address or email it with scanned signature page to the above email address.

Document Submission Information (submit the following to DNR)

- ✓ Cover Letter (optional)
- ✓ Sections 1-3 are required. Use Section 4 as needed for additional leases.
- ✓ A \$500 filing fee is required for application of rental relief of each lease. If multiple leases are included in the application, a separate filing fee is required for each. Fees may be paid by including a check or money order made payable to the Department of Natural Resources (11 AAC 05.110(d)(3)(I)).
