**General Information and Instructions**

This packet is intended as a supplement for use with Packet A, the Application for Assignment of Working Interest or Initial Separation of Overriding Royalty Interest, and is designed to facilitate the transfer of working interest or initial separation in multiple leases. The packet can accommodate 25 leases. However, applicants may save as many copies of the document as necessary to complete their transfer application.

**Submit one copy of each Lease Assignment Detail Sheet.**

Each sheet must:

- Have one ADL number listed. The segment should be filled in if the transfer is for a specific segment.
- Contain the assignor's current ownership (five or fewer digits to the right of the decimal unless previously approved), amount to be assigned, the amount the assignor is retaining, and any existing overriding royalty interest being transferred. The initial separation of overriding royalty interest field should be completed as necessary when applicants are creating a new overriding royalty interest.
- Include the correct lease legal description for the land being transferred. Legal descriptions can be obtained from the on-line Alaska Department of Natural Resources Land Administration System. Only the legal description for the lease should be included. **Do not** submit the unit or participating area legal description or include reference to any unit or participating area. Applications containing this information will be returned to the applicants for corrections.

Effective December 26, 2019, a \$250 filing fee is required for each lease assignment. Fees may be paid by including a check or money order, made payable to the Department of Natural Resources. (11 AAC 05.110(d)(3)(M))

**Final Packet Submission**

The final assignment application packet should include:

- Cover letter (optional).
- Completed Assignment Packet A, including three original signed copies of the application's signature page, regardless of the number of leases being transferred.
- One copy of Packet B Lease Assignment Detail Sheets, as necessary.
- A check or money order payable to the Department of Natural Resources for the appropriate filing fees.
